Shadowing Opportunities Available for 2022 Suit Up for the Future Program

The Louisiana State Bar Association, in partnership with Just the Beginning, is again hosting the Suit Up for the Future Program this summer, a free three-week legal institute for high school students and recent graduates interested in pursuing careers in the legal profession.

The 2022 program is set for June 13 through July 1. During the program, students attend an abridged law school

session, take field trips to law schools and courts, and participate in an internship consisting of shadowing at area law offices and courts.

Legal professionals are being asked to participate in shadowing opportunities. During the program's second week (June 20-24), students will be assigned to "shadow" attorneys at firms, courts and organizations. This is an opportunity for the students to see for themselves what

attorneys do on a daily basis and to spend one-on-one time with attorneys in the workforce. Attorneys and firms, in the New Orleans area, interested in providing a shadowing opportunity for one or more students should email diversity@lsba.org.
