Courts, Community, and Collaboration: 6th Annual Self-Represented Litigant Summit Recap

The 6th Annual Self-Represented Litigant (SRL) Collaborative Summit was held on May 2, 2025, at the 22nd Judicial District Court in Covington, drawing over 50 legal professionals from across Louisiana. The event served as a dynamic platform for sharing innovative tools, strategies, and best practices for improving services to self-represented litigants in courts statewide.

The summit featured CLE-accredited sessions on a range of critical topics including:

- ► In Forma Pauperis (IFP) Procedures
- ► Ethical Engagement with Self-Represented Litigants
- ► Self-Help Center Models and Best Practices
- ► Artificial Intelligence and Court Form Development
- ► Systemic Barriers to Justice

Participants included judges and court staff from City and Judicial District Courts across the state—including representatives from the Louisiana Supreme Court—as well as members of legal aid and pro bono organizations, community partners, and private practitioners. This diverse group of attendees reflected the broad-based commitment to building a more inclusive, responsive, and user-friendly legal system.

Speakers and attendees alike shared practical insights for improving court navigation and support for SRLs, emphasizing the importance of collaboration across sectors. Discussions focused not only on current challenges but also on solutions that can be scaled and sustained.

The summit reaffirmed Louisiana's Access to Justice Commission and its Self-Represented Litigant Committee's dedication to ensuring that all residents — regardless of income or representation status — can meaningfully engage with the legal system. •

Developing Leaders in Legal Service: 2025 ATJ Interns Begin Six-Week Immersion

The Louisiana State Bar Association's (LSBA) Access to Justice (ATJ) Developing Leadership Intern Program began its ninth year on May 12. The six-week program places interns with nonprofit legal aid organizations and district judges, while also inviting them to numerous LSBA ATJ Departmentrelated meetings to provide a bird'seye view of Louisiana's civil legal aid network. The idea for this program was developed during an ATJ Summit where participants concluded that cultivating the next generation of access to justice leaders should not only be a priority. but is essential as part of succession planning to ensure continued efforts within Louisiana's justice community. This year's interns are working with the Baton Rouge Bar Foundation, Louisiana Appleseed, the Louisiana Coalition Against Domestic Violence (LCADV), Lagniappe Law Lab, Southeast Louisiana Legal Services, the New Orleans Pro Bono Project and the Parole Project. The interns also will observe Judge Bernadette G. D'Souza, Orleans Parish Civil District Court, and Judge Jeffrey C. Cashe, 21st Judicial District Court. In addition to their experiences with legal aid providers, interns are sponsored by law firms and organizations with a commitment to supporting access to justice in Louisiana.
