## **Speaker Bios**

**Denia S. Aiyegbusi** is a partner at Deutsch Kerrigan LLP. As part of the firm's civil litigation department, Denia works on cases ranging anywhere from small property subrogation claims, all the way to multi-million dollar, traumatic, brain injury, personal injury cases.

Ms. Aiyegbusi has successfully argued motions in both state and federal courts throughout Louisiana. As an appellate lawyer, she has successfully argued in the Louisiana Fourth Circuit Court of Appeal and briefed to the Louisiana Supreme Court.

Ms. Aiyegbusi graduated from Loyola University New Orleans College of Law in 2007. In 2016 and 2017 she was on the "Louisiana Rising Star" list. Denia currently serves as Co-Chair on LSBA's Diversity Committee and is also involved with the Minority Involvement Section.

Kim M. Boyle practices in the areas of labor and employment, civil rights, constitutional law, commercial, tort and general litigation. Her employment practice includes representing employers in employment related claims, such as retaliation and discrimination claims as well as workplace harassment. She also handles EEOC charges and other administrative complaints through the administrative and judicial process. Her practice also includes the representation of public and private clients in a variety of commercial disputes, including breach of contract, business torts, misappropriation of trade secrets, unfair trade practices and class actions, as well as representation of a number of governmental entities on an array of legal issues. Ms. Boyle is known for her persuasive oral argument skills in both trial and appellate courts, and for her ability to take a matter from inception through verdict at trial by jury or judge. Many of the matters Ms. Boyle handles have been resolved through trial, and she has completed a number of oral arguments before state and federal appellate courts. She speaks often on employment-related topics, litigation and issues of procedure, as well as ethics and professionalism issues. Ms. Boyle was recognized by Benchmark Litigation as one of the Top 250 Women in US Litigation in 2018 and is very active in local, state and national bar activities, as well as community organizations and initiatives. Ms. Boyle served as the first female African-American President of the Louisiana State Bar Association (2009-2010) as well as the first African-American President of the New Orleans Bar Association (2002-2003). She currently serves as a Board and an executive committee member for Tulane University and the New Orleans Business Alliance. She also serves as Chairman of the Board for the Amistad Research Center and is a Board member for Dillard University and Touro Infirmary. Ms. Boyle formerly served as Judge Pro Tempore for Civil District Court for the Parish of Orleans, as well as an Assistant Professor of Law at Loyola University College of Law and a member of Princeton University's Board of Trustees.

In addition, she was a member of the Louisiana Recovery Authority ("LRA") and served as Chair of the LRA Healthcare Committee. Ms. Boyle previously served on the Bring New Orleans Back Commission, which focused upon rebuilding the city post-Katrina, and served as Chair of the Health/Social Services Committee of the Commission. She received her J.D. from the University of Virginia School of Law in 1987 and her A.B. from Princeton University in 1984.

Sarka Cerna-Fagan is Assistant Dean for Compliance and Senior Director of Career Development at Tulane Law School. Before joining Tulane Law, she spent 10 years as a transactional corporate attorney in New York City. After graduating from New York University School of Law in 1993, she worked at White & Case for three years then at Paul, Hastings, Janofsky & Walker for almost five years. She then joined a mid-size law firm, Golenbock, Eiseman, Assor, Bell and Peskoe, where her broad corporate law practice included project finance, aircraft leasing, bank lending, venture capital and mergers and acquisitions. In private practice, Cerna-Fagan had years of career development experience, serving her firms in both recruiting law school students and training summer and junior associates. She has also participated as a panelist in workshops held by the NYU School of Law Career Counseling and Placement Office and volunteered as a mentor for the foreign-trained LLM students. She is admitted to practice in the State of New York and is a member of NALP–The Association for Legal Career Professionals.

Luis A.
