SPEAKER BIOS

Sarah W. Anderson is the owner/founder of SWA Law LLC and LegallyCyber.com. She is the chief legal counsel for the State of Louisiana's Emergency Support Function-17, responding to cyber incidents and conducting cyber law training across Louisiana. Prior to SWA Law, Sarah was of counsel with Alexander Sides Law Firm, in-house counsel with the Cyber Innovation Center (a technology innovation non-profit), and a former partner with a multi-state law firm, representing several fortune 500 companies in toxic tort litigation and property disputes. She also serves as a Judge Advocate in the U.S. Army Reserves and has served Brigade Judge Advocate for an Infantry Brigade Combat Team in theater, as well as a Cyber Law Judge Advocate for Louisiana and legal liaison for the Louisiana Cybersecurity Commission while with the Louisiana Army National Guard.

Eric K. Barefield is Ethics Counsel for the Louisiana State Bar Association (LSBA). A law graduate of LSU, Eric began his professional career as an Assistant District Attorney in Orleans Parish. He later served as Deputy Disciplinary Counsel with the Office of Disciplinary Counsel and was responsible for investigating and prosecuting violations of the Louisiana Rules of Professional Conduct. He joined the LSBA staff in 2005, working first with the Practice Assistance Program's alternatives to discipline. Eric is responsible for the LSBA's Ethics Advisory Service which is comprised of attorneys across the state along with Ethics Counsel and provides confidential non-binding ethics opinions to Louisiana licensed attorneys.

Honorable Susan M. Chehardy is the Chief Judge of the Louisiana 5th Circuit Court of Appeal. She was elected to the appellate bench in 1998 as the court's first woman judge (and reelected in 2012). Prior to the appellate bench, she served as judge for the 24th JDC, after an active general litigation personal injury practice with the firm of Chehardy, Sherman, Ellis and Breslin; and later with her own litigation firm, Chehardy & Nielsen. She also recently served as justice *pro tempore* for the Louisiana Supreme Court. A law graduate of Loyola University, she is a member of the Fifth Circuit Judges Association, the Fourth and Fifth Circuit Judges Association, the Association of Women Judges and the American Judicature Society, among other organizations. A frequent lecturer for the Louisiana Judicial College and the LSBA, she serves several committees and boards by appointment of the Louisiana Supreme Court.

Anderson O. "Andy" Dotson III is the Chief Disciplinary Counsel for the State of Louisiana. A native of Monroe, Louisiana, he received his JD, magna cum laude, from Southern University Law Center in 2000. Previously associated with Phelps Dunbar, LLP, he later served as the Parish Attorney for Baton Rouge while maintaining a private practice. He is a former member of the Louisiana Supreme Court's MCLE Committee, has served a two-year term on the Council of the Louisiana Law Institute, and is also a Past President of the Greater Baton Rouge Chapter of the Louis A. Martinet Legal Society among other local, civic, and bar association committees. He has also served as Chair of the Louisiana Disciplinary Board.
