#### **FAMILY LAW PROBLEMS**

divorce, custody, community property, domestic violence

#### **ESTATE PLANNING AND RESOLUTION**

wills, powers of attorney, living wills, successions

#### **FINANCIAL MATTERS**

bankruptcy, social security

#### **EMPLOYMENT**

termination, wage claims, civil rights

#### **DISASTER RELATED ISSUES**

### What do you need to do?

Call one of the numbers listed below to speak with an intake specialist.

Be prepared to be on the line for about 20 minutes.

You will be asked to provide your name and contact information before describing your legal problem. Depending on your legal problem, your social security number and detailed information about your income may be required. If telephone lines are busy or you are calling after hours, you may have to leave a message.
