Diversity/inclusion workshop coordinated with court renaming in Alexandria

he Louisiana State Bar Association (LSBA) partnered with the Alexandria Bar Association and the Louis A. Martinet Legal Society, Inc. of Central Louisiana to host a free, half-day diversity and inclusion workshop on Oct. 21, in connection with the renaming of the Alexandria City Court Building to the "Gravel Berry City Court Building." Louis Berry was the first African-American lawyer in Rapides Parish. At that time, attorneys had to be introduced in each judicial district court before they could file material in the court. Berry could not get a local attorney to introduce him. Attorney Camille Gravel stepped in and introduced Berry to the court. Berry then filed the suits that desegregated much of Louisiana. "They both, but I believe Mr. Gravel in particular, are real-life Atticus Finches who not only did not flinch when confronting the ills of our past, but charged headlong into the fights and, by the very fiber of their beings, caused others around them to recognize that things were not as they should be," said Zebulon Winstead, president of the Alexandria Bar Association.

Also participating in the renaming ceremony were Alexandria City Court Judge Richard Starling, Alexandria Mayor Jacques Roy, Alexandria City Council President Roosevelt Johnson, Louis Martinet Legal Society President Clifton Spears, and various members of the Gravel and Berry families.
