The Case Against Work-For-Hire Language In Sound Recording Agreements

Artist representatives are frequently asked to secure rights from individuals (e.g., producers, side artists, mix engineers, vocalists, and instrumentalists) rendering services in connection with an artist's sound recordings. There are a variety of methods to accomplish this, but the one that predominates the music industry by far is the "work for hire" approach. However, lawyers using work-for-hire language in agreements between creative collaborators inadvertently advance a "pro-industry" / "anti-author" position which is hostile to recording artists' statutory termination rights. This presentation explores the legal issues underlying the problem, the potential alternatives to the work-for-hire approach, and seeks to advance a new way forward for all practitioners.

Mr. Caldwell also does some advising for the U.S. Patent and Trademark Office on certain Intellectual Property and NIL issues.

His expertise spans the major live event productions to the development and production of global broadcast specials and television/docu-series projects. He was co-executive producer of Global Citizen Live.

Brian is a partner in the boutique entertainment law firm of Beame & Mencher LLP. He is also General Counsel & Head of Business Affairs at Global Citizen, a multi-national notfor-profit organization bridging digital media, humanitarian policy, and major event productions to help end extreme poverty NOW. As GC, Brian oversees all legal, compliance, and business affairs needs of the organization, and supports Global Citizen's international offices located in Canada, England, Australia, South Africa, Nigeria, and Germany. Most recently, Brian was integral in producing Move Afrika, a Global Citizen initiative in partnership with Kendrick Lamar and his creative imprint, pgLang to help build a touring circuit across the African continent.

Brian has also served as the chief legal architect for One World: Together At Home - a global broadcast event featuring over 70 distributors/broadcasters/digital platform partners, 70 performing artists, 50 celebrity talent, and a U.S. broadcast footprint across NBC, CBS, and ABC. As the lead on all legal and business affairs, Brian managed a team of in-house and outside counsel to navigate the legal and business affair needs within a three-week period. One World: Together At Home raised over \$127 million dollars to support the Covid-19 response. The program also broke two Guinness Book of World Records in the process. One World was followed-up by the organization's other international broadcast properties in 2020, including Global Goal: Unite For Our Future, Every Vote Counts, and Global Citizen Prize.

Prior to the pandemic, Brian played a prominent role in helping bring the Global Citizen Festival to Johannesburg, South Africa in 2018. In addition to overseeing the formation of a local South African office, he helped navigate the legal team through the production of the Festival - spanning strategy around sponsorship and partnership arrangements, production partnerships, securing comprehensive insurance coverage, global broadcast and digital rights deals, and artist engagements and music rights clearances.

Brian also works with outside legal counsel in over 20 jurisdictions throughout the world to shore up the organization's legal and compliance needs, including management and protection of Global Citizen's intellectual property portfolio, its media properties, and matters integral to operations as a nonprofit. Brian has served as a guest panelist at various entertainment law-related seminars, is a published legal scholar, and graduated in the top 3% of his law school class.
