### **2022 Online MCLE Limit**

On Feb. 11, 2022, the Louisiana Supreme Court issued an [Order](#) amending the online MCLE credit limitation for the current calendar year. The limitation on "self-study" credits has been increased to six (6) hours for the 2022 compliance period.
