**STIPULATION FOR EXTENSION OF TIME TO SERVE AN ANSWER OR
A MOTION UNDER FEDERAL RULE OF CIVIL PROCEDURE 12**

On August 27, 2019, Plaintiff Schuyler File filed Waiver of Service of Summons forms executed by counsel for Defendants Chief Justice Patience Roggensack, and Justices Ann Walsh Bradley, Annette Ziegler, Rebecca Bradley, Daniel Kelly, Rebecca Dallet, and Brian Hagedorn (the “Wisconsin Supreme Court Defendants”). Pursuant to their waiver of service, the deadline for the Wisconsin Supreme Court Defendants to serve an answer or a motion under Federal Rule of Civil Procedure 12 was October 21, 2019.
