## House of Delegates to Consider Four Resolutions at Jan. 24 Meeting

**T**he Louisiana State Bar Association's (LSBA) House of Delegates will consider four resolutions and other business items at its Midyear Meeting scheduled for Saturday, Jan. 24, at the Renaissance Baton Rouge Hotel.

The House will consider four resolutions:

- Resolution from the Bar Governance Committee proposing to amend the Bylaws to increase the penalty for late payment of dues from \$50 to \$100.
- Resolution from the Young Lawyers Division Council to amend its Bylaws to conform to LSBA Bylaws, to provide clarification and to align with current structure and operations.
- Resolution from the Outreach Committee to sunset the committee as a standing committee of the LSBA and to amend the Bylaws accordingly.
- Resolution from the House of Delegates Task Force to reduce the size of the House of Delegates and to amend the governing documents accordingly.

## LSBA Names Old Republic as New Endorsed Malpractice Insurance Provider

## Deadline Jan. 31 for Reporting CLE Credits

**T**he deadline is Jan. 31, 2026, for reporting continuing legal education credits for the 2025 calendar year. Preliminary transcripts were emailed to the membership in December from the email address [compliance@lsbamembership.com](mailto:compliance@lsbamembership.com).

All hours must have been earned by Dec. 31, 2025, and must be reported no later than Jan. 31, 2026, or late penalties will apply.

The annual requirement for attorneys is 12.5 hours, including 1 hour of ethics and 1 hour of professionalism credit.

Under the new partnership, LSBA members will see several improvements to their professional liability coverage, including:

- ▶ Opportunities for a claims-free deductible
- ▶ Additional deductible discounts for eligible policyholders
- ▶ Premium credits for standalone cyber liability policies
- ▶ Increased risk management credits
- ▶ Revised pricing criteria that offer more flexible rates for firms of all sizes

Together, these enhancements aim to make malpractice coverage more affordable and comprehensive for Louisiana practitioners.

LSBA members currently insured through the program will receive notice of the updated coverage beginning with January 2026 policy effective dates. Attorneys interested in joining the program will also have access to quotes for the enhanced, LSBA-endorsed policy starting in January.

For the LSBA, the move underscores its continued commitment to supporting the business and professional needs of its members. "This partnership represents the best of what our Association can do, leveraging relationships and expertise to bring tangible value to our members," Walters said.

## 2026 Judicial Interest Rate is 7.5%

Pursuant to authority granted by La. R.S. 13:4202(B)(1), as amended by Acts 2001, No. 841, the Louisiana Commissioner of Financial Institutions has determined that the judicial rate of interest for calendar year 2026 will be seven and one half percent (7.5%) per annum.

## Louisiana Supreme Court Announces Rule Updates and Enhanced Electronic Filing System

On Dec. 22, 2025, the Louisiana Supreme Court issued an order that repealed and re-enacted Rules I through XII and XLII, repealed Rule XIV, and adopted new Appendices G-1 and G-2, effective Jan. 1, 2026. The changes modernize court procedures and enhance electronic filing for attorneys practicing before the Louisiana Supreme Court.

The updated rules address filing requirements, including new formatting standards, deadlines, and confidentiality protections for sensitive information such as minors' identities and medical records. The revisions also affect civil and criminal case procedures governing records, briefs, motions, writ applications, oral arguments, and rehearings.

Amended Rule XLII governs electronic filing and allows attorneys to submit documents through the Court's secure electronic filing portal. Electronic filings are legally equivalent to paper filings and include requirements for registration, document format, filing fees, and error handling. Appendices G-1 and G-2 provide additional details regarding electronic filing fees, eligible document types, and terms of use. A sample cover sheet reflecting the updated filing requirements is available on the Louisiana Supreme Court's website at [www.lasc.org](http://www.lasc.org).

Further, pursuant to amendments to La. Code Civ. Proc. art. 253(B) (2) and La. Code Crim. Proc. art. 14.1(B) by Acts 2025, No. 352, §§ 1–2, effective Jan. 1, 2026, filings by attorneys licensed in Louisiana and in good standing with the Louisiana Supreme Court must be filed either in person in paper form or electronically through the Court's electronic filing portal in accordance with the Supreme Court Rules. Filings by all other litigants may be submitted by U.S.P.S., commercial courier service or in person.

## U.S. 5th Circuit Adopts Amendments and Local Rule Change

The U.S. Court of Appeals for the 5th Circuit has adopted amendments to its local rules, effective Dec. 1, 2025, to align with recent changes to the Federal Rules of Appellate Procedure.

One amendment revises 5th Circuit Rule 25.2.1 to clarify electronic filing requirements. After implementation dates set by the clerk, all cases will be assigned to the court's electronic filing system. Counsel must file briefs, motions, and petitions for rehearing in searchable PDF text format, not scanned documents, unless paper filing is specifically directed. Any paper filings must be identical to the electronically filed versions. Non-incarcerated pro se litigants may request permission to participate in electronic filing in civil cases.

The court also amended Rule 39 regarding taxable costs. The revised rule updates reproduction cost rates for briefs and appendices, confirms that required binding costs are taxable, and clarifies that mailing and commercial delivery fees are not recoverable as taxable costs. The amendment also restates the timing requirements for filing bills of costs and objections.

## Louisiana Act 352 Overhauls Court Filings Starting Jan. 1, 2026

Act 352 changes how Louisiana lawyers file court papers starting Jan. 1, 2026. After that date, attorney filings must be made either in person using paper or electronically through a clerk-approved e-filing system. For e-filings, a document is considered filed on the date and time shown on the system's acceptance confirmation. Approved e-filing systems include the parish courts' Louisiana Clerks' Remote Access Authority (LCRAA) portal and the independent filing systems of the five Courts of Appeal and the Louisiana Supreme Court.

The Act applies across civil and criminal matters. In courts that accept e-filings, the electronic record will serve as the official record, with separate treatment for trial/hearing exhibits in criminal cases. Public access to electronically filed records follows the same access rules that apply to paper filings.

A key compliance change is privacy: filers, not clerks, are responsible for ensuring that sensitive personal information is not included in public filings. Do not include

Social Security numbers, driver's license or state ID numbers, financial account numbers, full dates of birth, tax IDs, or any information protected from disclosure by law. Firms should add redaction checks to templates and workflows and train staff accordingly.

Only a narrow set of "original documents" may still be sent by U.S. mail or courier: original wills/testaments; original promissory notes or other authentic-form instruments; motions for default judgment that do not require a hearing (with supporting documentation); and any document the law requires to be an original. Everything else must be filed in person or e-filed.

Louisiana practitioners are urged to plan by choosing your default filing mode, verify which courts require filings in which manner, create a list of court or parish-specific platforms, update engagement letters and templates for redaction, and build a process to confirm e-filing acceptance near deadlines and train support staff on this change. Finally, as a general rule, attorneys should avoid

waiting until the last minute to file papers. Most courts do not provide IT assistance for filers outside of regular court hours.

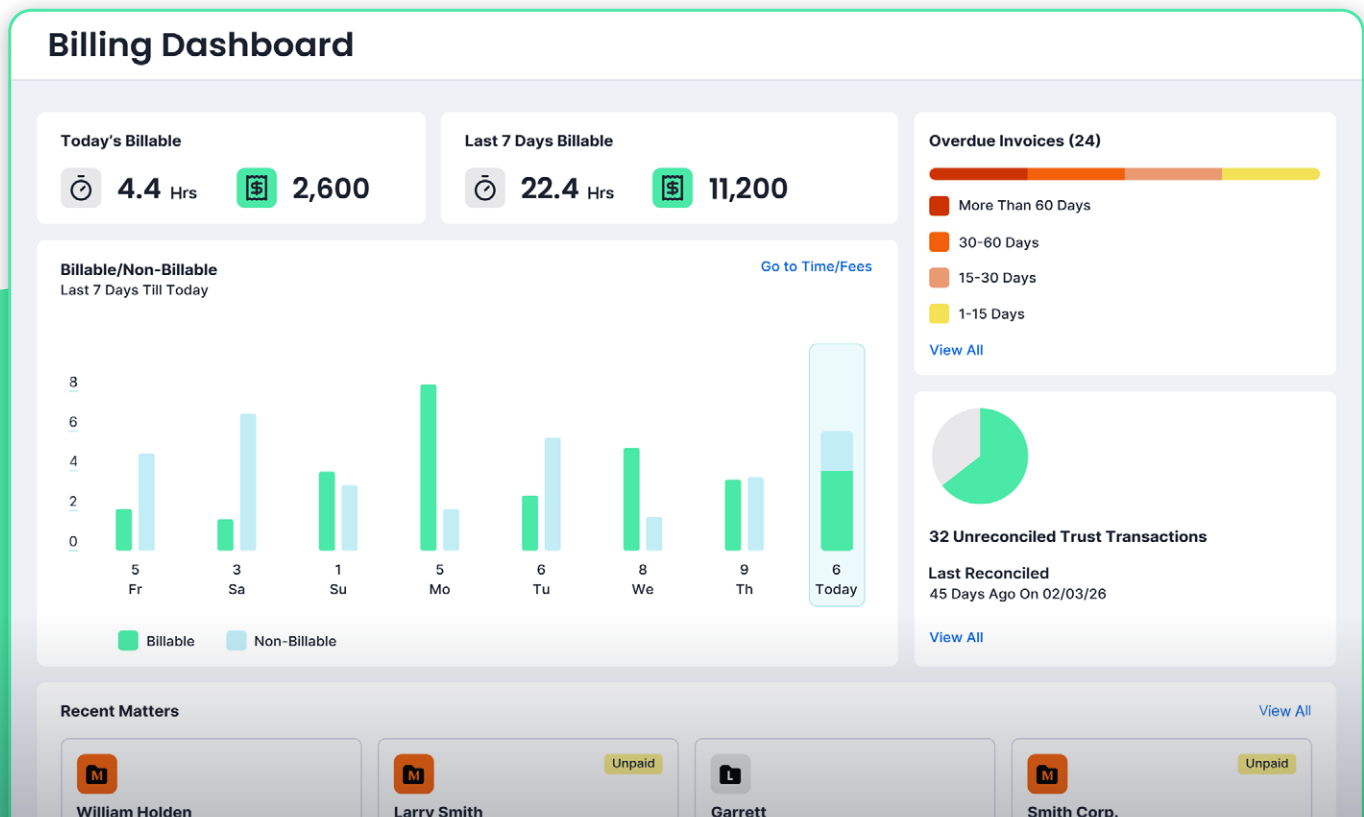

## Board Certified Specialists: Report Credit Hours to MCLE by Jan. 31 to Avoid Penalties

In accordance with the requirements of the Louisiana Board of Legal Specialization, board certified attorneys in specific fields of law had to meet a minimum CLE requirement for the calendar year ending Dec. 31, 2025. All attendance information must be delivered to the Mandatory Continuing Legal Education Committee (MCLE) no later than Jan. 31, 2026. Failure to earn and/or timely report specialization CLE hours will result in a penalty assessment. For the 2025 compliance period, the Louisiana Supreme Court set the limitation for “computer-based credit” at 4.0 hours annually. Preliminary specialization transcripts were sent in late November to all specialists who were delinquent in their specialization CLE hours for 2025. ## Louisiana Supreme Court Amends Plan of Legal Specialization

**T**he Louisiana Supreme Court has issued an order amending Sections 8.4, 9.2, and 10 of the Louisiana State Bar Association Plan of Legal Specialization.

The amendments recognize qualifying judicial and academic service as satisfying full-time practice requirements and establish an automatic inactive designation for board-certified specialists who take judicial office and are prohibited from practicing law. Specialists granted inactive status during judicial service are exempt from maintenance and recertification requirements and may apply for reinstatement to active status within one year of leaving office.

## LA Board of Legal Specialization Will Accept Applications for Board Certification Through Feb. 28, 2026

**T**he LBLS is accepting applications for board certification in seven (7) areas — appellate practice, employment law, estate planning and administration, family law, health law, labor law, and tax law from Nov. 1, 2025 through Feb. 28, 2026. The LBLS is accepting applications for business bankruptcy law and consumer bankruptcy law certification from Jan. 1, 2026 through Sept. 30, 2026.

In accordance with the Plan of Legal Specialization, a Louisiana State Bar Association member in good standing who has been engaged in the practice of law on a full-time basis for a minimum of five (5) years may apply for certification. Further requirements are that each year a minimum percentage of the attorney's practice must be devoted to the area of certification sought, passing a written examination to demonstrate sufficient knowledge, skills and proficiency in the area for which certification is sought and five (5) favorable references.

Peer review shall be used to determine that an applicant has achieved recognition as having a level of competence indicating proficient performance handling the usual matters in the specialty field. Please refer to the LBLS standards for the applicable specialty for a more detailed description of the requirements for application.

In addition to the above, applicants must meet a minimum CLE requirement for the year in which application is made and the examination is administered:

- ▶ Appellate Practice—15 hours of appellate practice
- ▶ Employment Law—15 hours of employment law

## **Bar Governance Committee**

The committee ensures effective and equitable governance of the association by conducting an ongoing evaluation of relevant procedures and making recommendations to the House of Delegates regarding warranted amendments to the association's Articles of Incorporation and/or Bylaws.

## **Children's Law Committee**

The committee provides a forum for attorneys and judges working with children to promote improvements and changes in the legal system to benefit children, parents and the professionals who serve these families.

## **Client Assistance Fund Committee**

## Committee on the Profession

The committee encourages lawyers to exercise the highest standards of integrity, ethics and professionalism in their conduct; examines systemic issues in the legal system arising out of the lawyer's relationship and duties to his/her clients, other lawyers, the courts, the judicial system and the public good; provides the impetus and means to positively impact those relationships and duties; improves access to the legal system; and improves the quality of life and work/life balance for lawyers.

## Rules of Professional Conduct Committee

The committee monitors and evaluates developments in legal ethics and, when appropriate, recommends changes to the Louisiana Rules of Professional Conduct; acts as liaison to the Louisiana Supreme Court on matters concerning the Rules of Professional Conduct; reviews issues of legal ethics and makes recommendations to the LSBA House of Delegates regarding modifications to the existing ethical rules; oversees the work of the Ethics Advisory Service and its Advertising Committee, Publications Subcommittee and other subcommittees; and promotes the highest professional standards of ethics in the practice of law.

## Transitioning Lawyers Committee

The committee safeguards the public by educating members of the legal profession about age-related disabilities. The committee also helps attorneys suffering from impairments that prevent them from practicing law competently to transition out of the practice of law with dignity.

## Unauthorized Practice of Law Committee

The committee protects the public from incompetent or fraudulent activities by those who are unauthorized to practice law or who are otherwise misleading those in need of legal services.

## 2026 Pro Bono Publico and Children's Law Awards Nominations

The Louisiana State Bar Association's (LSBA) Access to Justice (ATJ) Department is accepting nominations for the 2026 Pro Bono Publico and Children's Law Awards. These awards honor outstanding contributions to pro bono legal work across multiple categories. Recipients will be honored at the Louisiana Supreme Court in May 2026.

### Award Categories

#### Career Public Interest Award

This award recognizes an individual who has devoted at least 10 years to public interest legal work, demonstrating excellence, leadership, and service to the poor and disenfranchised.

#### Century Club Award

This award recognizes Louisiana attorneys who provided over 100 hours of verified pro bono service in the previous calendar year (Jan. 1, 2025–Dec. 31, 2025) through an established pro bono organization.

#### Children's Law Award

This award honors an attorney or organization for outstanding contributions to children's law.

#### David A. Hamilton Lifetime Achievement Award

The most prestigious LSBA Pro Bono Award honors a Louisiana attorney who has demonstrated a lifetime commitment to pro bono services.

#### Friend of Pro Bono Award

This award honors individuals (attorneys or non-attorneys), law firms, or organizations that have significantly enhanced pro bono services in Louisiana. Direct provision of legal services is not considered.

#### Law Student Pro Bono Award

This award recognizes a law student from each ABA-accredited Louisiana law school who has demonstrated exceptional dedication to providing legal services to the poor.

#### Pro Bono Publico Award

This award recognizes attorneys or law firms for providing exceptional pro bono services that exceed the aspirational goal of 50 hours of service per year, as outlined in Rule 6.1 of Louisiana's Rules of Professional Conduct.

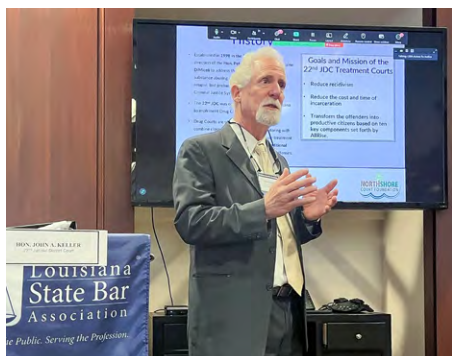
This year's training was also interpreted in its entirety by New Orleans Sign Language Services.

# ATJ Department's 2025 Top Accomplishments

As we look back on 2025, the Access to Justice Department extends its sincere gratitude to the supporters and partners who worked alongside us to advance access to justice for all. This past year marked the Access to Justice Commission's 10th anniversary, celebrating a decade of coordinated efforts that have expanded access to legal services. While the year brought both challenges and opportunities, through strong collaboration we made meaningful progress. Below are just a few of our shared accomplishments.

## 1 **Record-Setting Volunteerism During National Celebrate Pro Bono Week**

Louisiana marked a record-setting Celebrate Pro Bono Week in 2025 as our Lawyers in Libraries initiative, now in its 12th year, hosted 206 events with 192 volunteer attorneys contributing more than 500 hours of service, reaching every parish through in-person and virtual consultations. In addition, we led and participated in a range of statewide and multistate events, including a Free Legal Answers clinic with Entergy and Baker Donelson, law school presentations, a pro bono CLE for new admittees, and wills clinic in partnership with Louisiana Appleseed.

## 2 **Brought Pro Bono Leaders Together to Develop Statewide Priorities in a Summit Co-Hosted with the LBF**

The event brought together pro bono leaders, advocates, and program professionals from across the state and the ideas generated and strategic planning developed will be the focus of much of the ATJ's Pro Bono Subcommittee's work this year.

## 3 **Strengthened Louisiana's Disaster Response Through Coordinated Training**

In 2025, the Access to Justice community strengthened Louisiana's disaster response by co-hosting two major events with Southeast Louisiana Legal Services: a 20th-anniversary Hurricane Katrina legal symposium and the third Disaster Law Collaboration Summit. Together, these gatherings brought legal experts, policymakers, and community leaders together to address disaster preparedness, mitigation, recovery, and the long-term legal impacts of past disasters.

## 4 **Hosted Criminal Justice Summits for practitioners, judges, and stakeholders in Baton Rouge and Natchitoches**

The LSBA's Criminal Justice Committee expanded its statewide engagement by hosting two regional summits that brought together prosecutors, defenders, judges, law enforcement, and policy advocates to address emerging issues in Louisiana's evolving criminal legal landscape. By holding events in both South and Central Louisiana, the Committee strengthened accessibility and collaboration to ensure that these conversations reached practitioners across the state.

## 5 **Conducted Trainings for Law Students on Their Role in Advancing Access to Justice**

ATJ delivered trainings at Southern University Law Center, Loyola University College of Law, and LSU's Paul M. Hebert Law Center to educate students on how they can help bridge the justice gap as future attorneys. The sessions emphasized the growing need for affordable legal services and highlighted pathways for meaningful involvement, including joining the Modest Means Directory and offering limited scope representation.

## 6 **Celebrated 22 years of statewide public-interest training for civil legal aid attorneys through the Louisiana Justice Community Conference and its Child In Need of Care (CINC) Pre-Conference**

This multi-day event brought together 150 civil legal aid attorneys from across the state to strengthen access to justice for underserved communities. This year's theme, "Tools for Effective Advocacy in a Changing Legal Landscape," guided 15 sessions, including topics related to CINC, emerging legal developments, organizational strategies, and practical advocacy skills among others.

## 7 **Hosted 6th Annual Disability Law Training Series**

For the first time, the Legal Services for Persons with Disabilities and Accessibility Committees jointly hosted the 6th Annual Disability Law Training Series, a hybrid event designed to expand the legal profession's understanding of issues affecting persons with disabilities and those with language access needs. This year's sessions covered topics such as the intersection of mental health and the judicial system,

pooled special trusts, and attorneys' obligations to secure interpreters.

## 8 **Expanded Rural Access to Justice Through Justice on the Geaux**

Justice on the Geaux events led by Acadiana Legal Service Corp. held in DeRidder, Lake Providence, Ferriday, and Harrisonburg brought free civil legal services and education to 74 community members. Participants received guidance on family law, successions, and veterans' services, and engaged with partner organizations to learn how to access legal resources and support in their communities.

## 9 **Held Third Annual ATJ Conclave to Support Judicial and Community Collaboration**

The event brought together judges, legal professionals, and community leaders from across Louisiana to advance coordinated strategies for closing the civil justice gap. This year's program highlighted expanded judicial engagement, strengthened partnerships with community organizations, and promoted scalable models and tools, including the Civil Legal Navigator, LEAP Law Talks, and statewide legal resource portals, to deepen collaboration and improve access to justice statewide.

## 10 **Updated IFP Resources Released to Address Statewide Access-to-Justice Challenges**

As part of this year's top achievements, the ATJ Committee, building on a decade of work with Louisiana Appleseed and recent input from its IFP Working Group, released an updated In Forma Pauperis White Paper and a new Reference Card to help judges, clerks, and attorneys address persistent IFP challenges across the state.

These accomplishments are made possible by the dedication of hundreds of attorney volunteers and the ongoing work of Louisiana's civil legal aid and pro bono organizations. Together, they play a critical role in ensuring access to justice across the state. ### LSBA Chief Justice Bernette Joshua Johnson Trailblazer Award

The LSBA Chief Justice Bernette Joshua Johnson Trailblazer Award was established in 2016. It combined two previous diversity awards — the Trailblazer Award (established in 2013) and the Human Rights Award (established in 2010). The Chief Justice Bernette Joshua Johnson Trailblazer Award is awarded by the Association annually in June at the LSBA's Annual Meeting. The nomination period runs from October through February. This award recognizes individual attorneys and judges who champion the ideals set forth by Chief Justice Bernette Joshua Johnson, the first African American chief justice of the Louisiana Supreme Court, who has always exhibited an unwavering commitment

to enhancing diversity and inclusion in the legal profession. Nominees must be admitted to practice in Louisiana. Judges must have been elected or appointed to a state or federal court in Louisiana; the lawyer or judge can be on active or inactive status and from any practice setting; and the lawyer or judge cannot be a current member of the LSBA's Committee on Diversity in the Legal Profession. The Chief Justice Bernette Joshua Johnson Trailblazer Award recipient should demonstrate a unique blend of experience, skills, and accomplishments that translate into successful diversity and inclusion efforts, which include, but are not limited to, the following:

Supporting and encouraging attorneys who are members of an unrepresented group within the legal profession to reach their career and personal potential;

- ▶ Ensuring opportunities for the advancement of diverse people through mentoring efforts and diversity outreach;
- ▶ Commitment to addressing issues of equality, fairness, and injustice in the legal profession; and
- ▶ Participation in community service activities that promote and broaden the diversity pipeline to the legal profession.

### LSBA Guardian of Diversity Award

The Guardian of Diversity Award,

established in 2013, recognizes non-profit groups, local and specialty bar associations, and public interest organizations that implement and advance diversity programs to promote and support diversity in the legal community. It is presented at the LSBA's Annual Meeting. The nomination period is October through February. Nominees can be bar associations, courts, law firms/departments, or community organizations (including non-profits and public interest organizations). Recipients should demonstrate the following diversity and inclusion efforts within the legal profession or the practice of law:

- ▶ Creating and implementing innovative strategies to promote and advance the concept and spirit of diversity and inclusion;
- ▶ Making a significant impact on diversity issues in the legal profession;
- ▶ Enhancing access and equality in employment, economic and educational opportunities in the legal profession;
- ▶ Advocating and promoting an understanding and awareness of diversity in the legal profession;
- ▶ Dedication to improving and bridging the relationship between diverse groups in the legal profession; and
- ▶ Proven commitment to creating a culture of diversity and inclusion in the legal profession. ♦

### Do You Know Any High School Students Interested in the Legal Profession?

Applications are now being accepted for the Louisiana State Bar Association's Suit Up for the Future High School Summer Legal Institute and Intern Program, scheduled for June 8–26, 2026.

The application deadline is May 4, 2026, for high school juniors, seniors, and students entering their first year of college in Fall 2026. Students may access the online application portal at [www.lsba.org/goto/suitup](http://www.lsba.org/goto/suitup).

The Louisiana State Bar Association, in collaboration with the Louisiana Supreme Court, Just the Beginning, and the Louisiana Law Schools, hosts an annual internship

program. This program is available to incoming high school juniors, seniors, and recent graduates interested in the legal profession. Students participate in a three-week legal institute that incorporates the following: an abridged law school session with lectures by professors from area law schools; tours of law schools and courts; job shadowing at local law departments, courts, and agencies; the opportunity to research and draft a legal memorandum addressing a mock fact problem; and an actual oral argument before real judges. Students provide their own transportation and housing. Over the course of the three-week program, participants are introduced to lawyers, legal documents, and the legal system—all designed to help them



consider one important question: “Do I really want to be a lawyer?”

### Attorney Job Shadowing Opportunities

Legal professionals are being asked to participate in job shadowing opportunities. During the program's second week (June 15–19, 2026), students will be provided with an opportunity to job shadow attorneys at firms, courts, and agencies. This is an opportunity for students to see what attorneys do daily and to spend one-on-one time with them in the workplace.
